Vaccination Updates

Second Dose Updates:

- Fixed vaccination clinic has resumed the administration of second doses for approximately 2900 HCW, including those from Hamilton Health Sciences and St. Joseph's Hamilton. These are taking place this week between February 10th and 14th
- Planning is underway for resumption of first doses for health care workers. The Province has **not yet** give direction to resume first does for health care workers
- Planning is underway with Public Health for large scale vaccination efforts
- Vaccination of all HHS/SJHH ALC patients designated for LTC or transitional care beds is underway
- Vaccination of all patients at the SHF will also be done this week
- Goal remains to vaccinate everyone at HHS who wishes to receive it timing based on supply

Ontario Hospital Association's (OHA) Panel Discussion on Vaccines

The panel features Dr. Peter Lin, Director of Primary Care Initiatives at the Canadian Heart Research Centre and CBC Health Columnist, Dr. Caroline Quach-Thanh, Chair of the National Advisory Committee on Immunization (NACI), and Dr. Brad Wouters, Executive Vice President of Science and Research at University Health Network. Pandemic Response Planning (Presented by Sharon Pierson)

Epidemiology Update (Presented by Dr. Dominik Mertz)

The provincial and local epidemiology continues to improve, and we now see the impact on our health care setting with less patients admitted with COVID, less exposures and contact tracings in the hospitals, and no new outbreaks.

There is a lot of media attention to an experimental study using mannequins to compare efficiency of masks in reducing exposure to tiny air particles. The study concluded that the fit of a medical mask can be improved by putting a cloth mask on top of a medical mask, or by knotting the ear loops. A one pager is being put together and will get widely shared that summarized the study, its limitations, and the take home messages. In short: knotting is supported if improving the fit, while double masking remains discouraged.

Request for Physician COVID Vaccinators – Community Large Site Provision

HHS and SJHH are key participants at the city's planning and operational tables for the coordinated provision of COVID vaccine. This work is a partnership with the hospitals, Public Health, Family Medicine, Hamilton Paramedics and the City of Hamilton. Family Medicine has been the predominant (but not the only) source of physician labour to date. The current planning efforts are focused on the ability to deliver on **10,000 vaccinations daily** commencing as soon as March 1, 2021.

There is an opportunity and a need to extend the invitation for physician vaccinators to ALL physician groups.

It is essential that we ensure that all vaccination staffing offers are provided with the certainty that they will NOT infringe on hospital clinical commitments, as well as potential hospital surge coverage.

This ask is fairly specific; we have approximately 48 hours to determine the coverage the MD community is able to contribute over a 12 week (minimum) period.

This information will then be collated centrally to present a proposed coverage model.

If you are able to offer availability please provide the following information:

- 1. Name

- 3. Approximate number of shifts per week you anticipate you would be willing and able to offer

REMINDER:

Effective immediately, physicians who are scheduled administer COVID-19 vaccines are eligible to be compensated under the **H409/H410 billing codes**. Attached is a message from the ADM outlining the terms for compensating physicians who participate in the COVID-19 vaccination initiative for HHS – below is an excerpt

Fee Code	Fee Code Description	Fee Code Amount	Effective
H409	COVID-19 Sessional Unit - per one-hour period, or major part thereof	\$170.00	March 2020
H410	COVID-19 Sessional Unit - per one-hour period, or major part thereof on Saturdays, Sundays, holidays or Monday to Friday afterhours (5pm-7am)	\$220.00	March 2020

The following provides clarity on eligibility requirements for billing under the H409/H410 fee codes:

- Unlike FFS billings, these codes must be billed with an <u>eligible group number</u> that has been assigned to the hospital coordinating the services. **The group code for HHS is M305**
- Payments will be remitted directly to the service provider's solo banking account rather than to the group
- The physician must be scheduled by a hospital or public health unit to provide these services.
- The H409/H410 codes are only eligible for work at eligible assessment centres
- The H409/H410 are also billable by all physicians who are re-deployed by HHS to long-term care and/or congregate care settings under certain conditions
